Boab Metals Limited (ASX: BML) ("Boab" or the "Company") is pleased to report that an upgrade to the Moonamang Road, a key



The Moonamang Road upgrade will significantly improve the quality and efficiency of access to and from the Sorby Hills project site and at the same time also deliver broad regional benefits to stakeholders across the East Kimberley including the Ord River Irrigation Scheme.

Importantly for Boab, the upgrade to the Moonamang Road compliments the investment by the Australian and Northern Territory Governments to upgrade the Keep River Plains Road, thus providing a continuous sealed road between Sorby Hills and the recently acquired Manbarrum Zinc-Lead-Silver Project located 25km to the east (see below).

The Keep River Plains Road works have been completed.
