HIGHLIGHTS

- Nouveau Monde will establish the **first two commercial-size purification modules** for its demonstration activities at the existing facilities of Olin Corporation in Bécancour, Quebec.
- Ready in the second half of 2021, the modular furnaces will have a nominal capacity to process up to 1,500 tonnes of purified battery-grade graphite per year, generating **substantial cash flow in the short term** .
- This milestone cements Nouveau Monde’s **vertical integration strategy** , enabling it to leverage the entire value chain, from mine to anode equipment.
- New World’s high-purity graphite products will target **high-growth markets** such as lithium-ion batteries, fuel cells, and heat dissipation wafers for 5G technologies.
