Six new companies have listed on the Toronto Venture Exchange in the last few weeks, **Kobo Resources**, **Mink Ventures Corp.**, **NOA Lithium Brines**, **Bulgold**, **Abasca Resources Inc.**, and **Bocana Resources Corp.**

Kobo Resources (TSX.V: KRI) is a **growth-focused gold exploration company** with a compelling new gold discovery in Cote d'Ivoire, one of West Africa's most prolific and developing gold districts, hosting several multi-million-ounce gold mines.

Mink Ventures Corporation (TSX.V:MINK) is a Canadian mineral exploration company exploring for battery metals (nickel, copper, cobalt) at its Montcalm project, which covers approximately 40 km² adjacent to Glencore's former Montcalm

Mine which had historical production of 3.93 million tonnes of ore grading 1.25% Ni, 0.67% Cu and 0.051% Co.

NOA Lithium Brines (TSX.V: NOAL) controls a 100% interest in approximately 43,000 hectares of claims located at the Rio Grande Salar in Salta Province, Argentina. It is approximately 70 km from the Company's Arizaro Project and 250 km from its Salinas Grandes Project.

Bulgold (TSX.V: ZLT0) is a gold exploration company focused on the exploration and development of mineral exploration projects in Europe. The Company controls 100% of two quality gold projects located in the Bulgarian portion of the Western Tethyan Belt: the Kutel Gold Project and the Kostilkovo Gold Project.

Abasca Resources Inc. – TSX.V: ABA – is a Canadian mineral exploration company focused on its Key Lake South Uranium Project in northern Saskatchewan.

Bocana Resources Corp., (TSX.V: BOCA) is a mineral exploration company, focused on the acquisition, exploration, and development of mineral properties in South America, specifically in Bolivia.
